ARTICLES OF INCORPORATION OF

SMALL BUSINESS DEVELOPMENT FOUNDATION, INC.

ARTICLE I:

So Monday Services The name of this corporation is the Small Business Development Foundation, Inc.

ARTICLE II:

The principal place of business and mailing address for the Foundation is:

ARTICLE III:

The purposes for which this Foundation is organized are:

- to encourage, solicit, receive and administer gifts and bequests of property and funds for educational, scientific and charitable purposes, all for the advancement of Small Business Development Centers of the Florida Small Business Development Center Network and its objectives;
- to enlist support and advice from the business, (b) educational and professional communities for the advancement and benefit of Small Business Development Centers of the Florida Small Business Development Center Network;
- this Foundation shall have all its powers authorized under Chapter 617, Florida Statutes and as it may subsequently be amended;
- this Foundation in exercising any one or more of such powers shall do so in the furtherance of the exempt purpose for which it has been organized as described in Section 501 (c) (3) of the Internal Revenue Code of the United States.

ARTICLE IV

The affairs of the Foundation shall be managed by a Board of Trustees of not less than nine (9) members. Their number, qualifications, terms of office and manner of selection shall be fixed in the by-laws of the corporation.

ARTICLE V

The initial registered agent and his address is:

ARTICLE VI

The Foundation shall have perpetual existence.

ARTICLE V11

These Articles of Incorporation may be amended at anytime by a three quarters vote of the members of the Board of Trustees.

ARTICLE IX

The by-laws of the Foundation are to be made, altered, or rescinded by the Board of Trustees in the manner set forth in the by-laws.

ARTICLE IIX

In the event of the dissolution or other termination of the Foundation, title to all assets shall vest in the Board of Regents of Florida, on behalf of the Florida Small Business Development Center Network, or its successor, to be used exclusively for the purposes for which this Foundation is organized.
