The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 671, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: Florida Home Loan Review Corporation. The principal place of business of this corporation shall be: 541 South State Road 7, Suite 6, Margate, Florida 33068.

ARTICLE II

The period of the duration of this corporation is perpetual, unless dissolved according to law. The corporate existence shall commence upon filing of these Articles with the Secretary of State.

ARTICLE III

The purpose(s) for which the corporation is organized is: To establish and operate a volunteer group of mortgage and real estate industry professionals in the review of mortgage loans to assure and maintain quality lending.

ARTICLE IV

The qualifications for members and the manner of their admission are set forth in the bylaws.

ARTICLE V

The corporation is organized under a non-stock basis.

ARTICLE VI

In the event of a dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Government for exclusive public purpose.
