# Spruce Creek Fly-In Action Committee, Inc.

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I - Name**

The name of the corporation is: Spruce Creek Fly-In Action Committee, Inc.

#### **ARTICLE II - Principal Office and Mailing Address**

The street address of the principal office is: 100 Cessna Boulevard, Suite A, Daytona Beach, Florida 32124.

#### ARTICLE III - Purpose for which the Corporation is Formed

This corporation is a not-for-profit corporation. This corporation's purpose is limited to the pursuit of its goals, and is organized exclusively to explore the feasibility of the Spruce Creek Fly-In Community incorporating as a municipality under the laws of the State of Florida, as well as to perform the work and make the necessary expenditures associated with the Spruce Creek Community becoming a municipality under the laws of the State of Florida.

#### **ARTICLE IV - Dissolution**

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to the Spruce Creek Property Owners' Association, Inc. or a not-for-profit fund,

foundation, or corporation which: a) is organized and operated as an allowable not-for-profit corporation within the meaning of Sections 501(c)(3) or 501(c)(4) of the Internal Revenue Code of 1986 as amended or the corresponding provision of any future United States internal revenue law; and b) has established its tax exempt status under Sections 501(c)(3) or 501(c)(4) of the Internal Revenue Code of 1986 as amended, or the corresponding provisions of any subsequent federal tax laws.
