ONE: The name and address of this principal corporation is WORD OF LIFE MINISTRIES INTERNATIONAL OF BROWARD COUNTY, INC. 4950 NW 42ND CT. **Oakland Estate, Lauderdale Lakes, Florida 33319.** The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. To establish structured support services for homeless and economically disadvantaged individuals, families and juvenile to a life of self-sufficiency. The programs will consist of, but shall not be limited to Child care, outreach advocacy programs for the youth at high risk, health care, homeless, housing for the aged, employment, literacy, counseling, temporary shelter, teenage pregnancy, job training, job placement and acquisition, substance abuse awareness and prevention, tutoring, AIDS and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


