**ARTICLES OF INCORPORATION**  
**OF**

Article 1. Name. The name of the Corporation is Sports Psychology Training Associates, Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the corporation is as follows:

A. This corporation is a not-for-profit educational corporation organized under Chapter 617, Florida Statutes. It is not organized for private gain of any person. The specific purposes of this corporation are:

1) To provide psycho-educational instruction in the methods and techniques implicit to the field of professional sports psychology to parents and other adults who are supportive of young people involved in sports.

2) To provide counseling and guidance to parents and other adults functioning as personal trainers to young people involved in sports for the purpose of enhancing and strengthening positive family and child-adult bonding.

B. This corporation will exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit or be distributable to its directors, or officers; but the Corporation shall be authorized an empowered to pay reasonable compensation to these people for professional services rendered.

Article 4. Initial Registered Agent and Office. The initial registered agent is: David Altschuler and the initial registered office is 1850 Lee Road, Winter Park, Fla. 32789

Article 5. Initial Board of Directors. The Initial Board of Directors shall have 3 members whose names and addresses are:
