for**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The undersigned hereby declares that the name of the not for profit corporation shall be *THE PRESS COALITION, INC.*

**ARTICLE II**

For the purposes of conducting business under the name *THE PRESS COALITION, INC.*, the principal office and mailing address shall be:

**ARTICLE III**

The primary purpose of *THE PRESS COALITION, INC.*, is to build strong communities by developing a diverse coalition between varying religious denominations. *THE PRESS COALITION, INC.*, will achieve this goal by working diligently to develop community based programs that are designed to empower the down trodden by enhancing the ecumenical leadership necessary to implement tutorial, job training, and leadership development programs.

**ARTICLE IV**

The method for electing the Board of Directors for *THE PRESS COALITION, INC.*, shall be provided for in and governed by the bylaws of the corporation.

**ARTICLE V**

The corporation shall have perpetual duration.

**ARTICLE VI**

The Board of Directors of *THE PRESS COALITION, INC.*, shall govern the affairs of the corporation. The duties, powers, and method of election of the directors shall be determined by the bylaws of the corporation.

## ARTICLE VII

In the event of dissolution of *THE PRESS COALITION, INC.*, the assets are to be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding sections of any future Federal Tax Code.
