

We, the undersigned, hereby Amend the Articles of Incorporation for Coconut Grove Village West Homeowners and Tenants Association, Inc., a Florida not-for-profit corporation, as follows:

Article IV Tax Exempt. As a part of our application for recognition of exemption from federal income tax, we agree to make the following amendment to our organizing document:

- 1. The Coconut Grove Village West Homeowners and Tenants Association, Inc. is organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code of 1986, as amended, or to any corresponding provision of any future federal tax law.
- 2. Upon the termination, dissolution or final liquidation of the organization in any manner and for any reason, the organization shall first pay or provide for the payment of all liabilities of the Corporation; all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. "THIS AMENDMENT REPLACES ARTICLE IV OF OUR ORIGINAL

ARTICLES OF INCORPORATION"

Article VI Limitation of corporate powers. As part of our application for recognition of exemption from federal income tax, we agree to make the amendment to our organizing document: (See Attached)

Article VI Limitation of corporate powers

Add to second paragraph. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
