We, the undersigned, acting as incorporators of this Nonprofit Corporation adopt the following Articles of Incorporation.

Article I. Name And Principle Office

The name of this Nonprofit Corporation is

Article II. Affiliation

This Nonprofit Corporation is a subordinate member of Kingsway Ministries, Inc. a/k/a Kingsway Fellowship International and is pledged to promote and fulfill its purposes.

Article III. Registered Office And Agent

The street address of the initial registered office of the corporation is 26907 69th Avenue East, Myakka City, F34251 and the name of the corporation's initial registered agent at that address is Jan B.Otting.

Article IV. Purpose

The purpose of this Corporation shall be the propagation and dissemination of the Gospel of Jesus Christ, through the preaching, teaching, and living of the full gospel message as outlined in the Articles of Faith of Heaven Sent Ranch Ministries, Inc.

To accomplish such purpose the Corporation may, among other means, establish Christian Schools and colleges, home and foreign missions outreaches, hold

evangelistic crusades, and ultimately be engaged in all types of religious and charitable activities including evangelism through electronic broadcasting, AM & FM radio, telecasting, cable and satellite television, and any other related projects for the carrying out of these ministries.

Article V. Rights

It shall have the right to possess, buy, mortgage, sell, lease, barter and exchange real and personal property, to borrow money, collect funds, receive gifts and legacies as it may judge necessary for the attainment of these purposes.

This corporation is organized and operated exclusively for religious purposes. No part of the net earnings shall inure to the benefit of any private individual. No substantial part of the activities shall consist of the carrying on of propaganda, or otherwise attempting to influence any political campaign on behalf of any candidate for public office.

The affairs of the corporation shall be managed by its Board of Directors. The number of directors shall be at least three (3) and no more than three. Article XII. Amendments
