Constitution and Bylaws
Amendment; Article III # N990000 341
Board of Directors

Section 2-Number, tenure and qualifications. The number of Directors shall be no less than three (3) no more than five (5). The initial Directors shall be set forth in the Articles of Incorporation. Thereafter, the Directors are to be selected at the annual meeting of the Board of Directors or a special duly called meeting for that purpose; and shall be elected by a majority vote of the Directors of the corporation.

Section 3-Regular Meetings. A regular annual meeting of the Board of Directors shall be held once a year, unless otherwise specified by the Board Directors. The Chairman (normally the President) of the Board of Directors may set additional meetings throughout the year by notifying all Board members in writing at least 30 days prior to such meetings.
