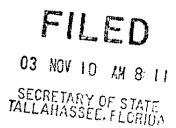

Restated Articles of Incorporation Of Heaven Sent Ranch Ministries, Inc.



We, the undersigned, acting as incorporators of this Non-profit Corporation adopt the following Restated Articles of Incorporation.

Article I. Name and Principle Office

The name of this Non-profit Corporation is:

Article II. Affiliation

This Non-Profit Corporation declares itself to be an independent according to the Florida Statues governing non profit Organizations. Heaven Sent Ranch Ministries, Inc. has no legal subordinate affiliations with any other churches or ministries.

Article III. Registered Office and Agent

Article IV. Purpose

No Substantial part of the activities shall consist of the carrying on of propaganda, or otherwise attempting to influence any political campaign on behalf of any candidate for public office.

Article VIII. Management of Affairs

The management of the affairs of the Corporation is vested in the President (Chairman of the Board)Senior Pastor and the Board of Directors.
