The undersigned incorporate, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

III. PURPOSE: This corporation shall be NOT FOR PROFIT. The purpose of this corporation shall be to accept donations which donations shall be used for the sole purpose of providing jewish education and the advancement of hebrew studies. Such donations shall be used exclusively in such charitable and educational purposes that qualify for exemption from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended or corresponding provisions of any future United State Internal Revenue Code and the regulations promulgated thereunder.

This corporation shall not conduct or carry on any activities prohibited from being conducted or carried on (a) by an organization exempt from Federal taxation under Section 501 (c) (3) of the Internal Revenue Code and the regulations thereunder, or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) if the Internal Revenue Code and the regulations promulgated thereunder.

Under the provisions of Section 501 and 4945 of the Internal Revenue Code, this corporation may not grant funds to be used to carry on propaganda, to attempt to influence legislation, or to participate in, or intervene in or attempt to influence the outcome of political campaigns or elections.

IV. MANNER OF ELECTION OF DIRECTORS: The Board of Directors shall be elected or appointed in accordance with the manner provided in the corporate bylaws.

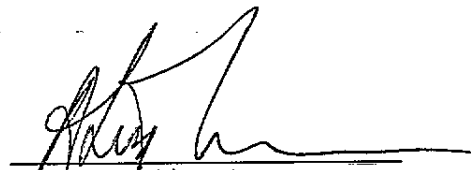

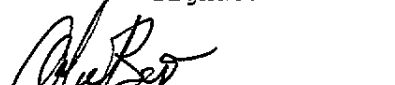

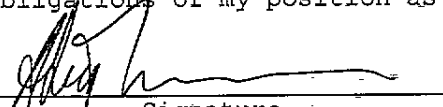
