## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### ARTICLE I

The name of the corporation shall be: The Mary and Elizabeth Project, Inc.

### ARTICLE II

The principal place of business and mailing address of this corporation shall be:  
4500 Dike Road, Winter Park, Florida 32792.

### ARTICLE III

The specific purpose of The Mary and Elizabeth Project is to provide assistance to unwed pregnant teenagers, seventeen (17) years of age or younger. This will be attained through partnership alliances with faith and community based organizations and the Christian community. The focus of The Mary and Elizabeth Project, Inc. is to link compassionate Christians in nonjudgmental relationships with pregnant teenagers.

### ARTICLE IV

The manner in which the directors are elected or appointed is: The nominating committee of the organization is responsible for selecting and screening candidates, and presenting their recommendations for approval by the organizational body.

### ARTICLE V
