# ARTICLES OF INCORPORATION OF FRIENDS OF THE JACKSONVILLE-BALDWIN RAIL TRAIL, INC.

The undersigned, acting as incorporator of a corporation pursuant to the Florida Not-for-Profit Corporation Act, Florida Statutes, adopts the following Articles of Incorporation.

#### **ARTICLE 1**

The name of this Corporation shall be Friends of the Jacksonville-Baldwin Rail Trail, Inc.

#### ARTICLE II

The purposes of this Corporation are to:

- (1) Act as a not-for-profit corporation to support the best interests of Friends of the Jacksonville-Baldwin Rail Trail, Inc.
- (2) Generate and employ additional resources for Friends of the Jacksonville-Baldwin Rail Trail, Inc.
- (3) Exist and operate solely for charitable, educational, and/or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and no part of the income or assets of the corporation shall be distributed to, nor inure to the benefit of, any individual, including the making of distributions to organizations that qualify as exempt under Section 501 (c)(3) of the Internal Revenue Code (or corresponding sections of any future federal tax code).
  - (4) To operate without regard to race, age, sex, religion or national origin.
- (5) To carry out its functions such that no substantial part of the Corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.
- (6) Do all things and transact all business which may be done lawfully by any person or individual, not inconsistent with the above or the rights and purposes of a non-profit corporation.
