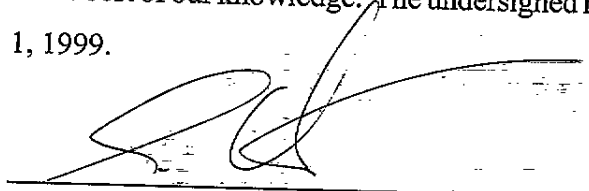

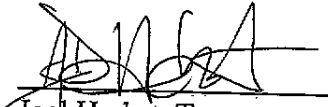
### LIABILITY OF DIRECTORS

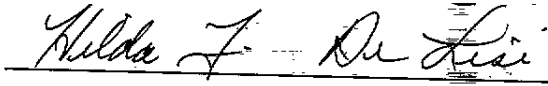

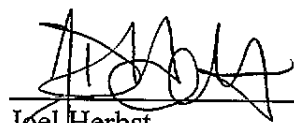
