ARTICLE I.

Name

The name of this Corporation shall be: Seabreeze Alumni Association, Inc.

ARTICLE II.

Duration

The duration of this Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE III.

Purpose

The primary purpose for which this Corporation is formed is to provide an organization for alumni of Seabreeze High School (the "School") to serve the common interests of all alumni and the School. In particular this Corporation's purposes include:

- (a) Keep alumni well informed about the School.
- (b) Foster and promote the active interest, support and involvement of alumni in Corporation and School affairs.
- (c) Encourage public acceptance and support of the School's goals, understanding of its problems and recognition of its achievements.
- (d) Maintain the official demographic history of the graduates of the School.

ARTICLE IV.

Non-Stock and Non-Profit

This Corporation shall have no capital stock, and no shares of stock in the Corporation shall be issued. This Corporation does not contemplate the carrying on of a business, trade, avocation or profession for profit, and does not contemplate the making or distributing of any pecuniary gains or profits to its members.

ARTICLE V.

Board of Directors

The number of Directors constituting the initial Board of Directors is three (3) and the name and address of each person who is to serve as a member thereof are as follows:

The number of Directors may be changed from time to time in accordance with the by-laws but shall never be less than three (3). Election or appointment of the Directors shall be as prescribed in the by-laws.

ARTICLE VI.

Membership

Membership in this Corporation shall be limited to alumni of Seabreeze High School. The rights, terms, obligations, conditions, rules, privileges, qualifications, admission, suspension and termination of membership of the members of this Corporation shall be set forth in the corporate By-Laws and shall be binding upon the incorporator and upon all subsequent members of the Corporation.

ARTICLE VII.

By-Laws

At the first meeting of the members of this Corporation there shall be adopted corporate By-Laws which shall prescribe the manner in which, and the officers and agents by whom, the purposes of the Corporation shall be carried out, and the manner in which the By-Laws may be amended. At the said meeting, the By-Laws shall be adopted by the vote of a majority of all the members of the Corporation. Notwithstanding the foregoing, the By-Laws may be adopted by written action in lieu of a meeting, with the consent of a majority of all the members of the Corporation.

ARTICLE VIII.

Principal Office and Registered Agent

The street address of the principal office of the Corporation is 150 Magnolia Ave., Daytona Beach, FL 32114. The name and address of the initial registered agent of the Corporation is Palmetto Charter Services, Inc., a Florida corporation, 150 Magnolia Avenue (Post Office Box 2491) Daytona Beach, Florida 32115-2491.

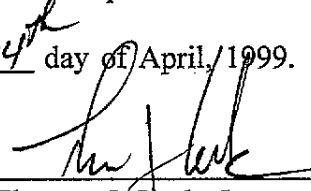

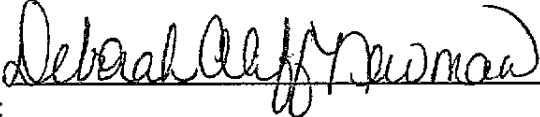
