ARTICLES OF INCORPORATION OF

El Shaddi Ministries of America, Inc.

The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a non-profit corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is El Shaddi Ministries of America, Inc.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be conducted by this corporation shall be to raise money and promote volunteer activity to educate and train un-wed mothers, as well as provide a place to deal with emotional wounds of children who were abused, neglected, or abandoned by parents; however, the corporation shall also have power to do all things that now are or may hereafter be allowed to non-profit corporations by the laws of Florida and by the laws of the United States of America.

ARTICLE III - DURATION

This corporation shall have perpetual existence and shall commence on filing. \Box

ARTICLE IV - CAPITAL STOCK

This corporation is not authorized to issue shares of stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The name and street address of the initial registered office of this corporation is:

ARTICLE VI - BOARD OF DIRECTORS

The corporation shall have three directors initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the directors but shall never be less than one.

ARTICLE VII - INITIAL DIRECTORS

The persons named as initial directors shall hold office for_one year or until a successor is elected or appointed and has qualified, whichever occurs first.

ARTICLE VIII - INCORPORATORS

The names and address of the persons signing these Articles are the initial Board of Directors and are listed above.

ARTICLE IX - LIMITATION OF POWERS

Notwithstanding any other provision of these articles, El Shaddi Ministries of America, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE X - ASSET DISTRIBUTION UPON DISSOLUTION OF THE CORPORATION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XI - AMENDMENT

The Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
