Articles of Incorporation of THE LENG FOUNDATION, INC. A Florida Nonprofit Corporation

STANA STEEL STORY

Article 1. Name.

The name of the corporation is: The Leng Foundation, Inc.

Article 2. Duration.

The duration of the corporation is perpetual.

Article 3. Purpose.

The purpose of the corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, of the Florida Statutes. It is not organized for the private gain of any person. The incorporator of this not-for-profit corporation recognizes a national need to re-establish family values as the foundational building block of a strong and stable society through the teaching of martial arts skills, alternative medicines, mental discipline, and spiritual development. To meet this need the corporation will provide financial assistance to families of children with special medical needs, sanctuary for abused and battered women and children, and provide spiritual and physical assistance to other non-profit organizations. Furthermore the corporation shall provide educational programs to enable people to obtain gainful employment. While providing educational opportunities, the corporation shall provide temporary housing to those individuals and families in need of such assistance.
- B. All students passing through the courses of instructions offered by The Leng Foundation are considered members of an extended family and as such become eligible to receive support to empower them in their efforts to re-establish a sound moral basis upon which the family can grow and prosper.
- C. Support is defined as and may include any or all or a combination of the following: (1) educational seminars, individual or group training, assistance in designing, locating, or preparing necessary fundraising materials, direct grants,

and/or interest-free short-term loans for the purchase of fundraising materials, supplies, required licenses, permits, registration, or qualification fees. (2) to provide educational scholarships to any student, regardless of race, creed, or national origin, who has demonstrated his or her support of the philanthropic principles by participating in, assisting in, sponsoring, or volunteering with any locally recognized community self-help or improvement program or activity.

- D. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- E. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and make payments and distributions in furtherance of its stated purposes.

Article 4. Members.

The corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights privileges of members of the corporation. The By-laws may provide for Non-voting Members of one or more classes, who shall be admitted in such number and who shall have such rights and privileges as are set forth in the By-laws, but who shall not have the right to vote. The By-laws shall provide for the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the By-laws, but shall in no case be less than three.
