**The specific purpose for which this corporation is organized is religious: i.e. to be a local
church formed to follow the principles and philosophy as outlined in the bylaws of the

Article IX. MEMBERSHIP PROVISIONS

The rights, qualifications, and obligations of members of this corporation are as found in the adopted By-Laws of this church and as lawfully amended subsequently as it was adopted by the membership at the first meeting of this church in the month of January, 1999.

Article X. ADDITIONAL PROVISIONS

The property of this corporation is irrevocably dedicated to church or religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of the minister, any director, officer, or member thereof or to the benefit of any private person.

Upon the dissolution or the winding up of the corporation, its assets remaining after payment, or provision of payment of all debts and liabilities of this corporation shall be distributed to a non-profit corporation which is organized and operated exclusively for religious purposes; to wit Unity School of Christianity, Unity Village, Missouri.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by section 501 (h) of the Internal Revenue Code). This corporation shall not

participate in, or intervene in, (including the publishing and/or distribution of statements), any political campaign on behalf of, or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under section 501 (c), (3), or (2) by corporation contributions to which are deductible under Section 170 (c) of the Internal Revenue Code.
