ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF CYPRESS LAKE COMMERCIAL LAND PROPERTY

Pursuant to the provisions of Section 607.1006, Florida Statutes and Article 10 of the filed Articles of Incorporation of Cypress Lake Commercial Land Property Owners Association, Inc.
