LIMITATIONS OF ACTIVITIES

Notwithstanding any other provisions of these Articles, this Corporation shall not carry on any activities not permitted

Dissolution can also become as a consequence of violations of rules and codes prescribed by the chartered parent, who will then have the power to convoque to a special meeting and declare a dissolution over such lodge for the reasons that have caused such actions to be taken.
