I, the undersigned, hereby submit the following Articles Of Incorporation under Chapter 617, Florida Statutes, which is subscribed and acknowledged to, and which is to be filed in the office of the Secretary of State of Florida.

ARTICLE I.

The name of this organization is BLACKMAN COMMUNITY CHURCH, INC., a non-profit organization.

ARTICLE II.

The initial office for the transaction of business for the organization shall be located at: 7878 Red Barrow Rd., Baker, Florida 32531.

ARTICLE III.

The purposes for which this organization is formed are:

1. To conduct worship services.
2. To proclaim the full Gospel of Jesus Christ and urge His salvation.
3. To further the Kingdom of God throughout the world.
4. To promote Bible study and training.
5. To encourage and develop Christian faith and growth.
6. To provide any and all type of assistances to those in need.
7. To conduct any further and all lawful business under the laws of the State of Florida.

In the event of dissolution of final liquidation of the corporation, all assets, rights and interest of the corporation shall be transferred to a non-profit organization that is non-profit as defined by the Internal Revenue Service in Section 501 (3) (c).

Non-voting Membership - - Shall be any individual attending and participating in the worship services on a regular basis located in the Blackman Community Church, Inc.

IX.

Removal for cause - Upon a majority of the Board of Directors and notification in writing any voting or non-voting member may be removed from the Board of Directors and fellowship by failing to be active or participating in the functions of the corporation and/or causing dissention and discord among other members and/or goals of this Corporation.

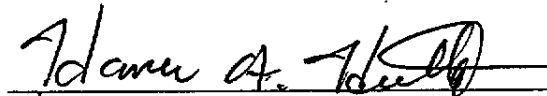
