Crystal River Community Tennis Association, Inc.**

The Not For Profit Articles of Incorporation of **Crystal River Community Tennis Association, Inc.** are filed as follows:

**ARTICLE I. Name**

The name of the not for profit corporation is **Crystal River Community Tennis Association, Inc.**

**ARTICLE II. Place of Business**

The initial principal place of business and the mailing addresses of the corporation are 2074 N. Watersedge Drive, Crystal River, FL 34429 (352) 795-1571.

**ARTICLE III. Purpose**

The purpose for which the corporation is organized is to promote junior tennis in the Crystal River, Citrus County area.

**ARTICLE IV. Members and Directors**

Each member family of the corporation with a participating junior in the tennis program will be entitled to voting rights on all business conducted by the corporation. The family will have one vote per family regardless of the number of juniors from the family that participate in the tennis program. Each director and each officer duly elected to office will be entitled to one vote each on corporation business. Regardless of the number of offices held, a person is entitled only to one vote.

The directors of the corporation will be elected every two years in staggered terms by a majority vote per director's seat at an election held at the annual meeting. There will be initially five (5) directors. Of the first elected Board of Directors three directors will be elected to two year terms, and two directors will be elected to one year terms. Thereafter each director will be elected to two year terms. The initial Board of Directors is:

#### ARTICLE VI. Articles of Incorporation and By-laws

The power to adopt, alter, amend, or repeal the Articles of Incorporation and By-Laws shall be vested solely in the members.
