*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:*

**Article I – Name**

The name of the corporation shall be Patronis Athletic Club, Inc.

**Article II – Principal Office**

The principal place of business and mailing address of this corporation shall be:

2433 Thomas Drive, Suite 127  
Panama City Beach, FL 32408

**Article III – Purpose**

The specific purposes for which the corporation is organized are to encourage, administer, and promote, on a not-for-profit basis, a football and cheerleader program for youth in the Panama City Beach area founded on the principles of good sportsmanship, respect, and personal growth and achievement.

**Article IV – Manner of Election of Directors**

The manner in which the directors are elected or appointed is: Elections for members of the Board of Directors shall be held annually in December, and any member of the Club shall be eligible to hold office. A Nominating Committee shall be appointed the first of October by the President and the Cheerleading Coordinator to accept nominations. Each person nominated shall be contacted and his permission to be included on the ballot shall be obtained. The committee shall submit the names of all nominees to the Board on November 1. A slot for write-in candidates will be included on the ballot.

Voting will be conducted at the annual awards ceremony. Club members shall be allowed only one vote per family. There shall be no campaigning. Newly elected directors shall assume their offices at the conclusion of the annual awards ceremony and shall hold office until the following year's ceremony.

Background checks may be required to insure that prospective directors have not been convicted of or pled no contest to the crimes of pedophilia, abuse, theft, or drug dealing. Drug tests may also be conducted.
