ADDING ADDITIONAL ARTICLES

ADDING ARTICLE VI : Statement of our Christian Faith.

Centro Cristiano de Amor y Fe, Inc (Christian Center of Faith & Love, Inc), **BELIEVE:**

(1): The full inspiration for the Holy Spirit of the sacred writings is the only and infallible rule of Faith and conduct. (2): In the Trinity, the eternal God the Father, God the Son and God the Holy Spirit; God in three persons. (3): In the plenitude of the deity of our Lord Jesus Christ and His real impeccable humanity. (4): That the Lord Jesus Christ was engendered by the Holy Spirit and was born of the Virgin Mary. (5) In the substitute and expiatory death of the Lord Jesus Christ in the cross. (6) The Lord Jesus Christ died in the cross for our sins and resuscitated the third day being raised by God the Father with the same glorified body that would return in power and glory. (7): That salvation for sovereign grace of God is reached by means of the faith in our Lord Jesus Christ. (8): In the regeneration of the human being for the Holy Spirit and the God's word.

Centro Cristiano de Amor y Fe, Inc. (Christian Center of Faith & Love, Inc), **BELIEVE:**

(9): That there are only two places as eternal destination of the soul; Heaven for the redeemed ones by the blood of Jesus Christ, and hell for the ones that rejected Jesus Christ. (10): In the spiritual unit of all the redeemed ones by the blood of the Lord Jesus Christ. (11): The need to maintain in accordance with the gospel the purity of the church in doctrine, in life and in conduct.

Centro Cristiano de Amor y Fe, Inc. (Christian Center of Faith & Love, Inc), **BELIEVE:**

(12): That God's church is the conglomerate of the redeemed ones by Jesus Christ. (13): We declare that Jesus Christ is the center of our faith, teaching and preaching and out of Him there is no salvation. (14): That the man was created in God's image, but for the disobedience he sinned and fell down of the state in which he was created. The whole human race remained involved in the sin of the man and therefore all the human beings are born with a lost and sinful nature and that the renewal for the Holy Spirit is absolutely essential for the salvation.

ADDING ADDITIONAL ARTICLES

ARTICLES VII : Statement of Christian Faith on Marriages, Gender and Sexuality

(1): We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God (Genesis 1:26-27). Rejection of one's biological sex is a rejection of the image of God within that person. Man and woman are created by God in His image and likeness and their should not reject their biological sex.

(2): We believe that the term marriage has only one meaning : the uniting of one biological man and one biological woman in a single, exclusive union, as delineated in Scripture (Genesis 2:18-. We believe that God intends sexual intimacy to occur only between a biological man and a biological woman who are married to each other. (First Corinthians 6:18, 7:2-5 & Hebrews 13:4)

(3): We believe that any form of sexual immorality, including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography, is sinful and offensive to God . (Matthew 15:18-20 & First Corinthians 6:9-10).

(4): We believe that in order to preserve the function and integrity of our church as the local Body of Christ, and to provide a biblical role model to our members and the community, it is imperative that all persons employed by our church in any capacity, or who serve as volunteers, agree to and abide by this Statement of Faith on Marriage, Gender and Sexuality. (Matthew 5:16; Philippians 2:14-16 & First Thessalonians 5:22).

(5): We believe that God is merciful to all sinners. He offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Romans 10:9-10 and First Corinthians 6:9-11).

(6): We believe that every person must be afforded compassion, love, kindness, respect, and dignity (Mark 12:28-31 & Luke 6:31). Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of our church.

(7): We believe that God has ordained marriage and defined it as the covenant relationship between a man and a woman, and Himself, our church only recognize marriages between a biological man and a biological woman.

(8): We believe that the senior pastor, the assistant pastors, ministers, staff and volunteer of our church shall only participate in weddings and solemnize marriages between one biological man and one biological woman that are members in good standing of our church. The senior pastor should marriage only staff members that has been active for at least two years. The assistant pastors should marriage active members of our congregation.

(9): We believe that the facilities and properties of our church shall only host weddings between a biological man and a biological woman.

ADDING ADDITIONAL ARTICLES

ARTICLE VIII : Statement of Church Membership Policy

(1): We believe that membership of our church is a privilege and shall be composed only of individuals who are believers in the Lord Jesus Christ and affirm the tenets of the Church Statement of Faith and the church's Statement of Faith on Marriage, Gender and Sexuality.

(2): We believe that all members should offer evidence, by their confession and their conduct, that they are living in according to the rule of faith and conduct of the Holy Bible and our church's Statement of Faith.

(3): We believe that to carry on the religious mission of the church, to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons who associate with the church as members should abide by and agree to the church's statement of membership policy.

(4): We believe the Lord Jesus Christ has entrusted the local church with the authority and responsibility to discipline members for flagrant sin or serious doctrinal error, with the goal of the restoration of the offender. This discipline is entrusted to the Pastoral Staff and is to follow the biblical pattern as set forth in Matthew 18:15-20; First Corinthians 5; Second Corinthians 2:7-8; Galatians 6:1; Second Thessalonians 3:6; Titus 3:10-11 and Second John 7-11.

(5): We believe discipline will follow the biblical pattern described on paragraph 4 , and is an effort to bring the individual to repentance and protect the church from unrepentant sin. Discipline may involve exclusion from participation in ministry and communion, as well as dismissal from the fellowship of our church.

(6): We believe that in order for an individual to apply for membership they should have been for at least two (2) years attending our services and must have a conduct according to the Holy Bible.

ADDING ADDITIONAL ARTICLE

ARTICLE IX : Statement of Religious Employment

(1): We affirm that the inspiration of the Holy Spirit gives the Bible its canonical authority, and the role of our church is to recognize and affirm this authority in all aspect and activities of the church. The church affirm and project that authority also by its employees and volunteers.

(2): We believe that all and every position within the church, employees and volunteers, furthers the church's religious mission and has to be filled by a person that his/her life is inspired and reflect the doctrine of faith and conduct according to the Holy Bible and the church's Statement of Faith.

(3): We believe that all and every employee and volunteer of the church is a minister and therefore has to agree, support and lives according to the church Statement of Faith.

(4): We believe that the "ministerial exception" is a legal doctrine that clearly state that churches are exempt from anti-discrimination laws in hiring and firing employees.

ADDING ADDITIONAL ARTICLE

ARTICLE X : Statement on Church Facility Use Policy

- (1): We believe the church's facilities and equipments were provided through God's benevolence and by the sacrificial generosity of church members and voluteers. The church facilities are used only for the fellowship of the Body of Christ and to bring God glory. The church's facilities are not open to the public.
- (2): We believe that the church's facilities use would not be permitted to persons or groups holding, advancing, or advocating beliefs or practices that conflict with the church's statement of faith or moral teaching that are summarized in the Articles of Incorporations.
- (3): We believe that, in no event shall persons or groups who hold, advance, or advocate beliefs, or advance, advocate, or engage in practices that contradict the church's faith use any church facility. The church's facilities should not be used in any way that contradicts the church's statement of faith.
- (4): This policy applies to all church facilities, regardless of whether the facilities are connected to the church's sanctuary or are not, because the church sees all of its property as holy and set apart only to worship God. (Colossians 3:17).
