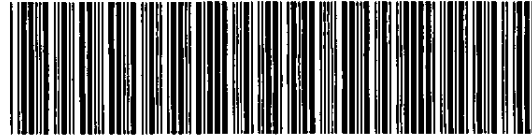

AMENDING ARTICLE III : PURPOSE

Paragraph 2 : In the event of dissolution of the corporation, the residual assets of the organization shall be turned over to one or more organizations which themselves are exempt organizations described in section 501 (C)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
