

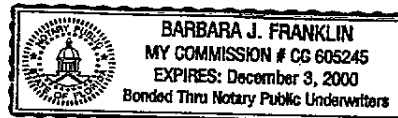

ARTICLE I

The name of this non-profit corporation shall be: Potter's House Fellowship, Inc.

ARTICLE II

At present, (03/27/99), the principle place of business and mailing address is: 1200 East McBerry Street, Tampa, Florida, 33603.

ARTICLE III

The purpose of organizing this non-profit corporation (church) is the *worship* of God, *fellowship* of Christian believers, *ministry* to people's needs and prayer.

ARTICLE IV

Officers and terms of service are as follows: Directors election shall be stated in

- 1) **Pastor** - Elected by congregation for an indefinite term of service.

By-Laws

Advisory Council:

- **Secretary** - Appointed by pastor to serve indefinitely.
- **Treasurer** - Appointed by pastor to serve indefinitely.
- **Director of Promotion** - Appointed by pastor to serve indefinitely.
- **Minister of Worship** - Appointed by pastor to serve indefinitely.

Other officers can be appointed by pastor as needed.

- 2) The pastor's service can be terminated by resignation, or a two-thirds vote of the membership, at a specially called business meeting. A business meeting for this purpose may be called for by the church advisory board, if all members of the board (excluding the pastor) unanimously agree that such a meeting is necessary.

- 3) All other officers can be relieved of their duties by the pastor.

ARTICLE V

Robert L. Morgan, pastor of Potter's House Fellowship, will serve as the initial registered agent. His residence, at present (4/14/99), is 1200 East McBerry Street, Tampa, Florida, 33603.

ARTICLE VI

Robert L. Morgan, pastor of Potter's House Fellowship, will serve as incorporator to these articles of incorporation. His residence, at present (4/14/99), is 1200 East McBerry Street, Tampa, Florida, 33603.
