**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of the Corporation shall be the SOUL WINNERS INTERNATIONAL
MINISTRIES, INC.

ARTICLE II. AUTHORITY

The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE III. INITIAL OFFICE AND AGENT

The street address of the initial registered office of the corporation is 151 North
Highway 27, Clermont, Florida 34711, and the initial registered agent at such
address, is Mark W. Saunders.

ARTICLE IV. PURPOSE

The corporation is organized exclusively for religious, educational, charitable
purposes, as well as to buy, purchase, own, acquire, by gift, devise, or otherwise, real
and personal property, and to build, erect, construct, provide for, maintain and
equip suitable buildings, churches, houses, etc....., for the benefit, and use and
occupation of the said SOUL WINNERS INTERNATIONAL MINISTRIES, Inc.,
and its associated member Churches. To maintain and foster public worship, and
the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and
for all other meetings and purposes of the said Soul Winners International
Ministries, Inc., its members and congregation. To build, construct, erect, maintain

and equip schools, churches, missions stations and mission churches, pastors' homes and such other houses or equipment as the church may desire for carrying on its work. To receive, administer, disburse and invest gifts, devises and bequests by or from any person or corporation. To issue bonds, notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust or otherwise. This corporation is organized for the purpose of holding the title to such property or properties as the said Soul Winners International Ministries, Inc., 151 North Highway 27, Clermont, Florida, 34711, shall, from time to time, purchase or acquire, and it Shall have power, from time to time, to make such contracts and to do such things as shall be authorized and directed by the Board of Directors and its members of the said Soul Winners International Ministries, Inc., 151 North Highway 27, Clermont, Florida evidenced by resolution of said Board. To do everything necessary, suitable or proper for the accomplishment, attainment or furtherance of (and to do every other act or thing incidental to, pertinent to, growing out of or connected with) the purposes, objects or powers set forth in these articles of incorporation, whether alone or in association with other; to possess all the rights, powers and privileges now or hereafter conferred by law upon a nonprofit corporation organized under the laws of the State of Florida, and, in general, to carry on any activities and to do any of the things herein set forth to the same extent as a natural person or partnership might or could do; provided that nothing herein set forth shall be construed as authorizing the corporation to possess any purpose, object or power to do any act or thing forbidden by the law to a nonprofit corporation organized under the laws of the state of Florida.

ARTICLE V. DURATION

The corporation shall have perpetual duration.

ARTICLE VI. MEMBERS

The corporation shall have members. Classifications and qualifications shall be specified in the by – laws.

ARTICLE VIII. DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of the federal government, for a public purpose.

Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization as said court shall determine, which are organizations as said court shall determine which are organized and operated exclusively for purposes.
