The corporate powers of this corporation are as provided in Section 617.0302 of the Florida Statutes.

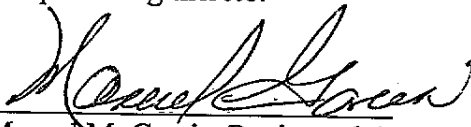
