ARTICLES OF INCORPORATION

Article 1. The name of said corporation shall be:

The Delta Tetarton Housing Association of Phi Sigma Kappa, Incorporated

Article 2. The principal place of business and mailing address of this corporation shall be:

Article 3. The specific purposes of the corporation is as follows:

To incur, promote, assist, finance, administer and execute programs and opportunities, fraternal, social and educational, for said fraternity chapter, its members and alumni, and in the furtherance of the same, to hold legal and equitable title to realty and personally which is devoted to the use and benefit of Delta Tetarton Chapter of Phi Sigma Kappa Fraternity, located at the University of Florida, Gainesville, Florida.

Article 4. The manner in which the directors are elected or appointed is as follows:

The Board of Directors shall be chosen by majority vote at the annual meeting of the members or at any meeting held in place thereof provided by law, and may be elected at the special meeting of members called for that purpose. Eligible board members are those Phi Sigma Kappa alumni who have graduated, are members in good standing and who have been alumni for a minimum of two years. Directors, when elected, shall serve, unless removed as hereinafter set forth, until the next annual meeting of members or other meeting of members called for the purpose of the election of a board of directors and until their successors are elected. Any Director or Directors may be removed, at any time, with or without any cause, by majority vote of the members at a duly called meeting.
