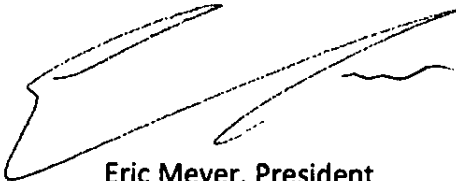

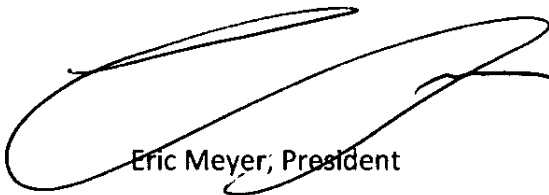

Third Article:

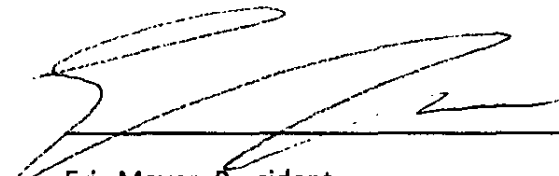
Delete: 435 Bulf (*sic*) Boulevard, Indian Rocks Beach, Florida, 33785-2705

Add: Principal office and Place of business are superseded by the registered office address

Fourth Article:

Amend paragraph (1) by appending :

"In addition to the foregoing, the corporation may, from time-to-time, engage in civic, social and philanthropic activities intended to improve and benefit the quality of life in the City of Indian Rocks Beach, consistent with its mission to enrich our unique small town quality."
