The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of this Corporation is Concord Baptist Christian Family Center, Inc. and the principal business address of the Corporation is Concord Baptist Christian Family Center, Inc., 10960 Indies Drive South, Jacksonville, FL 32246.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the earlier of (i) the date of filing of the articles of incorporation or (ii) May 1, 1999 and shall be filed with the Secretary of State within five (5) business days from May 1, 1999. This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of engaging in religious services and operating as a church.

ARTICLE VII - MANNER OF ELECTION OF DIRECTORS

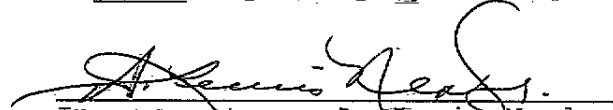

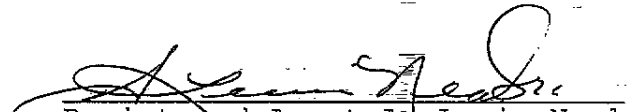
