Articles of Incorporation  
Of  
Central Asia School Enrichment Foundation **INC.**  
A Florida Nonprofit Corporation

Article 1. Name. The name of the Corporation is Central Asia School Enrichment Foundation Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purposes of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

1) To seek, collect, and provide humanitarian relief and assistance to the Central Asian Republics of the former Soviet Union : namely, Azerbaijan, Kazakstan, Kyrghyzstan, Tajikistan, Turkmenistan, and Uzbekistan.

2) This humanitarian assistance shall take many forms, including but not limited to monies, material goods, or services in the form of teaching, counseling, medical care, or guidance given to teachers, professors, administrators, leaders, parents, or students.

3) This humanitarian assistance shall be provided for schools, institutes, colleges, universities, kindergartens, orphanages, institutions, jails and other groups as decided by the Board of Directors.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers, but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Initial Registered Agent and Office. The initial registered agent is Suzanne Carol Stanley and the initial registered office 7060 Berry Road, Zephyrhills, FL 33540.

Article 5. Initial Board of Directors. The initial board of directors shall have seven members, whose names and addresses are:

The number of directors may be raised or lowered by amendment of the bylaws but in no case be less than three. Directors shall serve terms, shall be added, or shall be removed, according to the bylaws. Directors shall be the only voting members of the corporation.

Article 6. Officers. The officers of the corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. 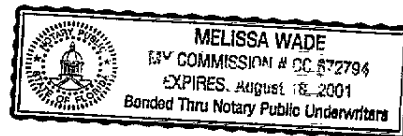
