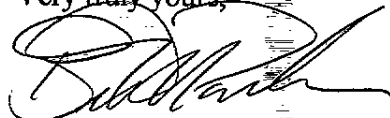

**ARTICLES OF INCORPORATION  
OF  
CRESTVIEW OFFICIALS ASSOCIATION, INC.  
(A non-profit corporation)**

The undersigned subscriber(s) to these Articles of Incorporation, each being a natural person and competent to contract, hereby associate themselves to form a CORPORATION NOT FOR PROFIT under the Laws of the State of Florida:

**ARTICLE I.**

THE NAME of the corporation is:

**CRESTVIEW OFFICIALS ASSOCIATION, INC.**

**ARTICLE II.**

THE PURPOSES for which the corporation is formed, and the objects to be carried on and promoted by it are:

- a. To conduct various efforts and undertakings for the moral and social well-being of youth, youth activities, sporting events and to serve the community by officiating all youth sports;
- b. To inspire the youth of the community and promote sportsmanlike conduct in all youth activities and sporting events..

**ARTICLE III.**

THE QUALIFICATIONS and the manner of admission of the members of this corporation shall be set forth in the by-laws herein authorized of their corporation,

**ARTICLE IV.**

THE PRINCIPAL PLACE of business of this corporation is 3646 Poverty Creek Road, Crestview, Florida 32539.

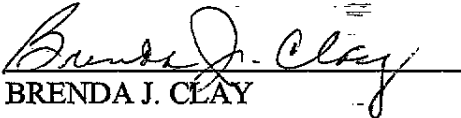
**ARTICLE IX.**
