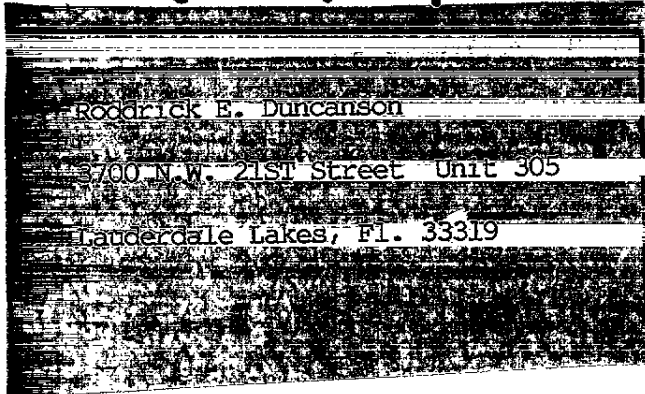

ONE:

The name and address of this principal corporation is Duncanson's Caring For Others Ministries, Inc. 3700 N.W. 21ST St. Unit 305 Lauderdale Lakes, Fl. 33319 in Broward County. The corporation is organized pursuant to the **FLORIDA Nonprofit Corporation Code.**

TWO:

This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Laws for Religious purposes. 
