ONE: The name and address of this principal corporation is Johnny & Patti Kemp Ministries, Inc., 3950 N.W. 177th Street Miami, Florida 33055. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). 


