ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of Conch Farm Research & Education Foundation, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME; PRINCIPAL ADDRESS

Conch Farm Research & Education Foundation, Inc.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the dates of filing of these Articles of Incorporation.

ARTICLE III. DURATION

The corporation will have a perpetual existence.

ARTICLE IV. PURPOSE

The general purpose or purposes for which the corporation is organized are as follows:

(a) To engage in every aspect and phase of scientific research and the education of residents of and visitors to Florida regarding Florida history, environmental issues, aquaculture, ocean and ocean reef life, and to engage in every aspect and phase of related purposes.

(b) To transact any or all other lawful purposes for which a not-for-profit corporation may be incorporated under the Florida General Corporation Act.

ARTICLE V. AUTHORIZED SHARES OR MEMBERSHIP CERTIFICATES

The maximum number of shares or membership certificates which can be issued at the direction of the Board of Directors is 10,000 shares or certificates, having no par value.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 631 Greene Street, Monroe County, Key West, Florida 33040, and the name of the corporation's initial registered agent at that address is Dean E. Rollings.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

vote on the matter or in such other manner as may be provided by law.
