OF

- One: The name of the corporation shall be God's Women of Destiny Inc.
- Two: The principle place of business of this corporation shall be 11775 SW 273rd ST, Homestead, Florida 33032, in Miami Dade County. The mailing address of this corporation shall be P. O. Box 924067, Homestead, Florida 33032.
- Three: This corporation is a nonprofit public corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law, for religious, charitable, and educational purposes, to aid the poor, needy, destitute, hungry, homeless, and disadvantaged individuals towards a life of self-sufficiency. The programs shall consist of, but shall not be limited to: ministering to the spiritual needs in our community, feeding the hungry, clothing the poor, destitute and needy, engaging in health and wellness education, family training and education, counseling, tutoring, and purchasing, leasing, or otherwise acquiring and holding lands and buildings for the offices and premises of the corporation, jobs training, elderly care, Substance Abuse and Aids Awareness and prevention, and other programs to aid those in need.
- Four: The corporation shall have perpetual existence.

Seven: This corporation is organized and operated exclusively for religious, charitable, and educational purposes.

Eight: The property of this corporation is irrevocably dedicated to religious, charitable, and educational purposes, and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof, or the benefit of any private person.

Nine: On the dissolution, or winding up of the corporation, its assets remaining after payment of, or provision for payment of all debts and liabilities, shall be distributed to a nonprofit fund, or corporation which is organized and operated exclusively for educational and charitable purposes under Section 501(C) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Plea of the county in which the principle office of the organization is located exclusive for such purposes, or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.
