- FIRST: The corporate name that satisfies the requirements of Section 617.0401 is Vietnam Veterans of America, Inc., Chapter #831-Melbourne, FL.
- SECOND: The purposes for which the corporation is organized are: The Vietnam Veterans of America, a congressionally-chartered veterans service organization is dedicated to promote and support the full range of issues important to Vietnam veterans and their families through legislation, employment, education and benefits programs.
- THIRD: The address of the principal office and the mailing address of the corporation is 4650 Knoxville Avenue, Cocoa, FL 32926.
- FOURTH: The street address of the initial registered office of the corporation is 4650 Knoxville Avenue, Cocoa, FL 32926, and the name of its initial registered agent at such address is Bill Chapman.
- FIFTH: This corporation is organized under a non-stock basis.
- SIXTH: The method of election of directors is stated in the bylaws.

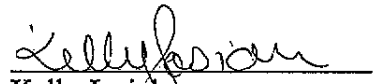
- EIGHTH: In the even of dissolution, the assets of the corporation will be distributed among the Florida State Council of the Vietnam Veterans of America.

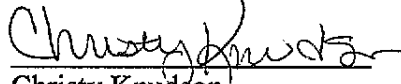

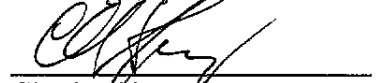
