The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be Homeless Coalition Of Martin County, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

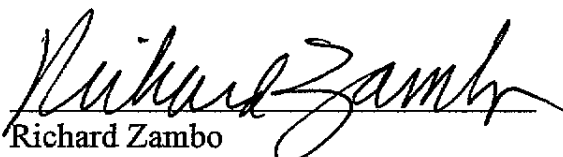
