ARTICLES OF INCORPORATION

FOR

UNITED HUMANITARIAN FRONT, INC.

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

UNITED HUMANITARIAN FRONT, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

3690 S.W. 64 Avenue
Davie, Florida 33314.

ARTICLE III-PURPOSE(S)

The specific purposes for which the corporation is organized are:

1. To function as an organization to insure the respect of property and personal rights; to conduct a civic and social welfare organization for the common benefit of the members and the community; to develop individual rights as a philosophy of life; to promote an active interest in good government and civic affairs; to inspire respect for the law, to promote patriotism and work for international accord and friendship among all people; to aid and encourage the development of youth.

2. The corporation shall not engage in any business of a kind ordinarily carried on for profit, and nothing in the Articles of Incorporation or in the constitution or bylaws shall authorize the corporation to, and the corporation shall not enter any transaction, carry on any activity, or engage in any business for pecuniary profit, and any income received by the corporation shall be applied to the non-profit purposes and objectives of the corporation set forth herein, and no part thereof during membership or upon termination of membership shall inure to the benefit of any private member or individual.

3. To engage in any lawful act or activity for which the corporation may be organized under the Articles of Incorporation.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed are as follows:

Such election of Directors shall be stated in the bylaws.

ARTICLE V - QUALIFICATION FOR MEMBERS

The qualification for members and the manner of their admission shall be stated in the bylaws.

ARTICLE VI - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE VII - INITIAL REGISTERED AGENT AND STREET ADDRESS
