ARTICLES OF INCORPORATION
OF

COVENANT REFORMED PRESBYTERIAN CHURCH

The undersigned, acting as Incorporators of a corporation not for profit, pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be COVENANT REFORMED PRESBYTERIAN CHURCH OF FORT PIERCE, FLORIDA, INC.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of the corporation shall be 4699 Oleander Avenue, Fort Pierce, Florida 34982.

ARTICLE III

PURPOSES

The specific purposes for which this corporation is organized are for the advancement of religion and any other related or corresponding charitable purposes by the distribution of its funds for such purposes, and to promote and encourage spiritual growth and development of its members.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The manner and method in which the directors are to be elected or appointed shall be as stated in the bylaws.
