ARTICLES OF INCORPORATION THE NORTH DADE YOUTH FOUNDATION, INC. 19455 N.W. 12 Avenue North Dade, Florida 33169



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be The NORTH DADE YOUTH FOUNDATION, INC.

ARTICLE II -PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III -CAPITAL STOCK

This corporation shall be a non-profit corporation without capital stock.

ARTICLE IV-PURPOSE

This corporation is organised for the purpose of transacting any and all lawful business for the promotion of the general welfare and morals of boys and girls under the age of twenty-one and the community, as a whole, in North Miami-Dade.

ARTICLE V - AUTHORITY

This corporation shall have the power to acquire, hold, and dispose of real and personal property, notes, mortgages, stock, bonds, securities, of all kinds and choices in action, and shall have power and authority to give and distribute its funds and properties to accomplish objectives.

ARTICLE VI -MEMBERSHIP

Each present member of the North Dade Youth Foundation, Inc., and such other persons as hereafter become members of said club, so long as they remain in good standing therein constitute the membership of the corporation, and members shall qualify and be admitted only upon proposal for membership by an active member of this corporation, in good standing, and upon a vote of approval of two-thirds of the members present at a meeting of this corporation.

ARTICLE VII -INITIAL REGISTERED OFFICE AND AGENT
