ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CHILD OUT-REACH, INC. A Florida Nonprofit Corporation

I

CORPORATE NAME

The name of the corporation is: Child Out-Reach, Inc.

The Articles of Incorporation are amended as follows:

- A) Article II -Principal Office shall be amended to state: "The principal place of business of the corporation is: 1610 Broadway, Riviera Beach, FL 33404
- B) Article III of the Articles of Incorporation is amended to add the follow language: "This corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
