OF

GREATER SAINT PAUL'S MISSIONARY
BAPTIST CHURCH OF ST. PETERSBURG, FLORIDA, INC.

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a not for profit corporation.

ARTICLE I

The name of the Corporation shall be: GREATER SAINT PAUL'S MISSIONARY BAPTIST CHURCH OF ST. PETERSBURG, FLORIDA, INC.

ARTICLE II

The existence of the Corporation shall be perpetual.

ARTICLE III

ARTICLE IV

The specific purpose for which the corporation is organized is to conduct church service, prayer meetings, revivals and any other manner of church-related business.
