The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **IGLESIA DE CRISTO MISIONERA EL TABERNACULO, INC.**
(The Misionary Church of Christ Tabernacul, Inc.)

ARTICLE II: PRINCIPAL OFFICE

ARTICLE X: AMENDMENTS

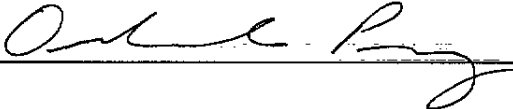
The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
