### ARTICLES OF INCORPORATION

FOR

## CHURCH OF THE GENTILE FAITH, INC.

## A FLORIDA NONPROFIT CORPORATION

I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the Laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation shall be: CHURCH OF THE GENTILE FAITH, INC.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be: 301 N. MYRTLE AVE., JACKSONVILLE, FL 32204

## ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE IV - PURPOSE

This corporation is organized:

- 1) To establish perfection in one mouth, as one man accordingly;
- 2) To fulfill the Laws of Moses, the Testimony of the Prophets and the Psalms;
- 3) To establish the Peace of God in His Household;
