**ARTICLES OF INCORPORATION
OF
DEDICATE YOUR CHILD BACK TO GOD**

THE UNDERSIGNED, ACTING AS INCORPORATOR(S) OF A CORPORATION PURSANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION OF SUCH CORPORATION.

ARTICLE I - NAME

THE NAME OF THE CORPORATION SHALL BE "DEDICATE YOUR CHILD BACK TO GOD, INC." THE PRINCIPAL PLACE OF BUSINESS OF THIS CORPORATION SHALL BE 4024 WATCH HILL ROAD, ORLANDO, FL 32808. THE CORPORATION MAY ALSO HAVE OFFICES AT SUCH OTHER PLACES BOTH WITHIN AND WITHOUT THE STATE OF FLORIDA AS THE BOARD OF DIRECTORS MAY FROM TIME TO TIME DETERMINE OR THE ACTIVITIES OF THE CORPORATION MAY REQUIRE.

ARTICLE II - DURATION

THE PERIOD OF DURATION OF THIS CORPORATION IS PERPETUAL COMMENCING WITH FILING WITH THE SECRETARY OF STATE, UNLESS DISSOLVED ACCORDING TO LAW.

ARTICLE III - PURPOSE

THE PURPOSES FOR WHICH THIS CORPORATION ARE ORGANIZED ARE:

- (a) TO ADVANCE SPIRITUAL GROWTH AND ENLIGHTENMENT, MORAL AND PERSONAL PURITY AMONG ITS MEMBERSHIP AND THE PEOPLE OF THE COMMUNITIES IN WHICH IT IS LOCATED.
- (b) FOR THE ADVANCEMENT OF CHRISTIAN AND ANY OTHER RELATED OR CORRESPONDING CHARITABLE PURPOSES BY THE DISTRIBUTION OF RELIGIOUS AND EDUCATIONAL MATERIAL TO PERSONS AND ORGANIZATIONS THAT QUALIFY AS EXEMPT UNDER SECTION 501 (C) (3).
- (c) TO OPERATE EXCLUSIVELY IN ANY MANNER FOR SUCH RELIGIOUS PURPOSE AS WILL QUALIFY AS AN EXEMPT CORPORATION UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, OR UNDER ANY CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS COVERING CORPORATIONS QUALIFIED AS TAX EXEMPT (THE "CODE").
- (d) TO PROMOTE DOMESTIC AND FOREIGN CHAPTERS (MISSIONS).
- (e) TO AID IN THE MORAL AND RELIGIOUS DEVELOPMENT OF THE YOUTH OF IT'S MEMBERSHIP AND LOCAL COMMUNITTE.
- (f) TO BUY, RENT, LEASE, SELL AND OWN PROPERTIES AND INSTITUTIONS TO ACCOMPOLISH THE PURPOSES HEREIN STATED.

- (g) TO CONDUCT FOR SPIRITUAL GUIDANCE, MORAL REHABILITATION AND PERSON GROWTH, CENTERS, SCHOOLS AND SUCH OTHER INSTITUTIONS CONNECTED THEREWITH OF A RELIGIOUS, EDUCATIONAL, CHARITABLE, AND BENEVOLENT CHARACTER TO THE END OF ITS OWN MEMBERS AND OTHERS MAY BE GENERALLY INSTRUCTED AND GUIDED CONCERNING THE TENENTS OF CHRISTIAN LIFE.
- (h) TO ESTABLISH AND CHARTER CHAPTERS BOTH DOMESTICALLY AND INTERNATIONALLY FOR THE PURPOSES HEREIN AFORE STATED.

ARTICLE IV - MEMBERSHIP

EVERY PERSON WHO BELIEVES IN THE CHRISTIAN'S TENENTS OF FAITH AND OBSERVES THE BY-LAWS AND PURPOSES OF THIS CORPORATION, IS QUALIFIED AND ELIGIBLE FOR MEMBERSHIP IN THIS CORPORATION. THE MANNER OF ADMISSION TO MEMBERSHIP IS BY WRITTER APPLICATION AND APPROVAL BY THE BOARD OF DIRECTORS. THE PRESENT MEMBERSHIP OF "DEDICATE YOUR CHILD BACK TO GOD" (UNINCORPORATED) AND THOSE HEREAFTER ADMITTED TO SUCH MEMBERSHIP AND ALL OTHER CHARTER CHAPTERS SHALL CONSTITUTE THE MEMBERSHIP OF THIS CORPORATION.

ARTICLE V – BOARD OF DIRECTORS

THE NUMBER CONSTITUTING THE INITIAL BOARD OF DIRECTORS OF THE CORPORATION IS FIVE (5), AND THE NAMES AND ADDRESSES OF THE PERSONS WHO ARE TO SERVE INITIALLY ARE:

ARTICLE VII – DISSOLUTION

IN THE EVENT OF DISSOLUTION, THE RESIDUAL ASSETS OF THE ORGANIZATION WILL BE TURNED OVER TO ONE OR MORE ORGANIZATIONS WHICH THEMSELVES ARE EXEMPT AS ORGANIZATIONS DESCRIBED IN SECTION 501 (C) (3) AND 170 (C) (2) OF THE INTERNAL REVENUE CODE OF 1954 OR CORRESPONDING SECTIONS OF ANY PRIOR OR FUTURE LAW, OR TO THE FEDERAL, STATE, OR LOCAL GOVERNMENT FOR EXCLUSIVE PUBLIC PURPOSE.

ARTICLE IX – OFFICERS

THE OFFICERS OF THIS CORPORATION SHALL BE MANAGED BY A GENERAL BOARD OF TRUSTEES. THE GENERAL BOARD OF TRUSTEES SHALL BE ELECTED FROM AND BY THE MEMBERSHIP OF SAID CORPORATION.

THE TERM OF TRUSTEESHIP SHALL BE FOR LIFE, OR FOR SUCH OTHER LENGTH OF TIME, NOT LESS THAN A YEAR, AS THE MEMBERSHIP OF SAID CORPORATION MAY PROVIDE IN ITS BY-LAWS.

THE SAID GENERAL BOARD OF TRUSTEES SHALL APPOINT FROM ITS OWN MEMBERSHIP A VICE-CHAIRMAN, SECRETARY AND TREASURER. THE PRESIDENT OF “DEDICATE YOUR CHILD BACK TO GOD, INC.” SHALL SERVE AS CHAIRMAN OF THIS BOARD. ALL LEGAL DOCUMENTS AND INSTRUMENTS OF THIS CORPORATION SHALL BE SIGNED BY SAID CHAIRMAN OR REGISTERED AGENT IF CHAIRMAN IS UNAVAILABLE, SEALED WITH THE CORPORATION’S SEAL AND ATTESTED TO BY SAID SECRETARY OR IN SUCH OTHER MANNER AS MAY BE AUTHORIZED BY LAW, OR IN THE BY-LAWS OF THIS CORPORATION.

ALL ELECTIONS TO MEMBERSHIP OF SAID GENERAL BOARD OF TRUSTEES SHALL BE BY TWO-THIRDS (2/3) MAJORITY OF THE MEMBERS OF THE CORPORATION PRESENT AT ANY BUSINESS MEETING OF SAID CORPORATION.

THE PRESENT GENERAL BOARD OF TRUSTEES OF "DEDICATE YOUR CHILD BACK TO GOD, INC.". NAMELY REV. VIVIAN M. BEAMER, REV. DR. FAYBELLE F. EADY, REV. BENNY G. EADY, REV. CONNIE BULLARD, REV. TEVITT SULLIVAN, SR. SHALL CONSTITUTE THE GENERAL BOARD OF TRUSTEES AND SHALL HOLD OFFICE UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.

THIS CORPORATION SHALL HAVE A PRESIDENT, VICE-PRESIDENT, SECRETARY, TREASURER AND FINANCIAL SECRETARY AND SUCH OTHER OFFICERS AS MAY BE NECESSARY SHALL BE ELECTED BY A TWO-THIRDS (2/3) MAJORITY VOTE OF THE CORPORATION PRESENT AT ANY BUSINESS MEETING OF SAID CORPORATION FOR SUCH TERM AS THE CORPORATION MAY PROVIDE BY ITS BY-LAWS.

ANY PROPOSED AMENDMENT TO THE CHARTER OF THIS CORPORATION MAY BE MADE AT ANY ANNUAL MEETING UPON A TWO-THIRDS (2/3) VOTE OF THE MEMBERS PRESENT, OR IN CASE OF AN EMERGENCY, AT ANY CALLED MEETING WHEREBY ALL MEMBERS SHALL BE DULY NOTIFIED AS PRESCRIBED IN THE BY-LAWS OF THIS CORPORATION.

ARTICLE XIII – INDEBTEDNESS

THIS CORPORATION SHALL SUBJECT ITSELF TO ANY AMOUNT OF INDEBTEDNESS OR LIABILITY AS AUTHORIZED BY THE GENERAL BOARD OF TRUSTEES AND APPROVED BY A TWO-THIRDS (2/3) VOTE OF THE MEMBERS PRESENT AT DAY BUSINESS OF SAID CORPORATION, DULY CALLED AND ANNOUNCED TO ITS MEMBERSHIP.
