ARTICLES OF INCORPORATION AMERICAN ANTI-AGING FOUNDATION, INES MAY 12 PM 3: 16

a Florida Not-for-Profit Corporation

SECRETARY OF STATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

AMERICAN ANTI-AGING FOUNDATION, INC._

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. <u>PURPOSE</u>

Said corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)(3).

ARTICLE IV. POWERS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to make payments and distributions on in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation,

contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future federal tax code).

ARTICLE V. DEDICATION OF ASSETS

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VI. MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The members of the Board of Directors shall be elected by majority vote of the Committee.
