- ONE:** The name and address of this principal corporation is **B & P Henry Ministries, INC.** 3613 SW 21st Court Ft Lauderdale Florida 33312 This Corporation is Organized pursuant to **FLORIDA Non-profit Corporation Code.**
- TWO:** This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of **JESUS CHRIST**. The Corporation is organized under the Non-profit Public Benefit Corporation Law for Religious purposes to establish structured support service for Evangelistic, Economic Development and other Ministries to support the outreach ministries for the body of **JESUS CHRIST (The Church)**. In accordance with the Doctrine of the corporation creed/by-laws as a Pastor to spread the gospel of **JESUS CHRIST**. The religious program will consist of Economic Development Programs, but shall not be limited to Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
