**ARTICLES OF INCORPORATION
OF
NATIONAL ASSOCIATION OF GUIDE & SERVICE DOG HANDLER'S,
INC.**

ARTICLE ONE - NAME

THE NAME of this corporation shall be "National Association of Guide & Service Dog
Handler's. Inc."

ARTICLE TWO - PRINCIPAL PLACE OF BUSINESS

THE PRINCIPAL PLACE of business and the mailing address of this corporation shall be

ARTICLE THREE - PURPOSE

THE PURPOSES for which **NATIONAL ASSOCIATION OF GUIDE & SERVICE DOG
HANDLER'S, INC.** is organized are exclusively charitable, and it is the purpose of this
corporation to help provide public education about guide dogs used by the blind and visually
impaired. It is further the purpose of this organization to provide public education to businesses
about access rights pertaining to guide dogs used by the blind and visually impaired. It is further
the purpose of this organization to provide advocacy for blind and visually impaired guide dog
handler's who encounter access problems with their guide dogs by means of educating businesses
on access rights, and acting as a mediator where access rights are violated so as to promote a
better understanding between the community, business, and guide dog handler's.
Notwithstanding any other provisions of these Articles this organization shall not carry on ANY
activities not permitted to be carried on by an organization exempt from Federal Income Tax
under Section 501(c)3 of the Internal Revenue Code of 1986, or the corresponding provision of
any future United States Internal Revenue Law.

ARTICLE FOUR - MANNER OF ELECTION OF DIRECTORS

THE MANNER of the election of Directors is to be provided for in the Bylaws.

ARTICLE FIVE - NON APPLICABLE

ARTICLE TEN - NON PROFIT STATUS

NATIONAL ASSOCIATION OF GUIDE & SERVICE DOG HANDLER'S, INC. is a non-profit corporation, incorporated under the provision of the Internal Revenue Service Code, Section 501(c)3.
